Bay 1 is a substantial modern single storey warehouse unit of steel portal frame construction with a pitched and lined roof incorporating translucent roof panels, full height brick external elevation walls with block inner leaf and a solid concrete floor throughout.

Forming part of a larger building Bay 1 provides open plan lofty warehouse space with customer/personnel access at the front and a loading bay area at the rear served with two roller shutter doors (3.35m high by 2.26m wide) from a large, dedicated loading yard which can accommodate articulated vehicles.

The property has kitchen and wc facilities and a range of offices to first floor level at the front.

Externally the property sits in a large secure and gated estate and the site provides a substantial number of car parking spaces.

An inspection is thoroughly recommended.





SERVICES

We understand that all mains services are available; gas, water, and electricity, all separately metered.

Lighting is provided by LED downlight units and the property is also serviced with a sprinkler system.

Heating is provided by gas fired hot air blowers in the warehouse and a gas fired central heating system with radiators in the office areas.


